Motion: Whereas climate change (or global warming) due to human production of carbon dioxide is the greatest challenge to the future of life on earth;

Whereas Northwestern University is, and must remain a leader in the search for solutions to Climate Change;

Whereas a previous Senate Resolution endorsed (April 3, 2013) a student led petition to divest Northwestern's endowment of investment in coal production;

And whereas the current Senate has constituted a Special Committee to examine and if necessary recommend expansion of the scope of university teaching, research and investment in this area;

Therefore be it resolved that the Senate asks its Social Responsibility Committee (SRC) to investigate the issue of divestment in coal and other greenhouse gas producing fuels and if appropriate, be in contact with leaders of the Special Committee on Climate Change and the Anthropocene. By this resolution in addition, Senate members request to be periodically informed of the SRC's research and deliberation on this issue, and if appropriate be presented with a correlative resolution.
