What are my vision care benefits?

As a participant in a Blue Cross and Blue Shield of Illinois (BCBSIL) HMO Vision Rider benefit, you and your covered dependents are eligible to receive an eye examination and contact lens evaluation, fitting and follow-up once every 12 months, for the cost of your PCP or wellness copayment. Your vision care benefits are available through Davis Vision, Inc., a leading national provider of routine vision care programs. Your benefits include:*

- coverage for one eye examination every 12 months for the cost of your PCP or wellness copayment
- coverage for one contact lens evaluation and fitting after your examination copayment when selecting contact lenses, when performed on the same day as your eye examination
- an allowance, plus discounts off retail cost, toward the purchase of eyeglasses (frames and standard spectacle lenses) and/or contact lenses,** once every 12 or 24 months, depending on your plan benefits.

Remember: Your copayment is due on the day of your visit. In addition, you must visit a Davis Vision network provider to receive coverage for a vision examination, your materials allowance or discount benefit.

Your plan provides an allowance that you can apply toward the discounted cost of eyeglasses or contact lenses.*** Eyeglasses (frames and standard eyeglass lenses) will be discounted*** by 40 percent off retail cost prior to applying the allowance. Contact lenses will be discounted*** 15 percent on conventional types, or 10 percent on disposable types, before applying the allowance. You can access your benefits a couple of different ways.

Independent Provider Locations

When you visit most participating independent provider locations, you will have an additional option for eyeglasses that will let you stretch your plan allowance even further. An Exclusive Collection of frames, provided by Davis Vision, will be available for you to select from. Should you choose any frame from the Exclusive Collection, along with eyeglass lenses, your final out-of-pocket cost will be reduced through a special pricing package offered to BCBSIL members by Davis Vision. This Exclusive Collection will allow you to maximize your vision benefit dollars. In addition, fixed discounted pricing on the most popular spectacle lens enhancements is available at offices displaying the Exclusive Collection.

Retail Locations***

The Davis Vision network also offers you the opportunity to receive services from leading retail locations, featuring Visionworks.® There are many convenient Visionworks locations in the Chicagoland area. In addition to the exceptional service available at Visionworks, there is an extensive selection of eyewear, including a large variety of children's frames. Visionworks offers polycarbonate lenses for children at no additional cost and deep discounts on additional pairs of eyewear.

You also can receive discounts on laser vision correction through Davis Vision, featuring the TLC/TruVision network. Discounted pricing on disposable contact lenses is available to you through Davis Vision's Lens 1 2 3® Mail Order Contact Lens Replacement Program. - Vision therapy
- Services performed by a provider who is not in the Davis Vision network
- Replacement of lost eyewear
- Services not performed by licensed personnel
