NRSA Institutional Allowance

• The Institutional Allowance is expected to be expended in the budget year in which it is awarded. If the Notice of Grant Award (NGA) specifically grants carryover authority, unspent funds from one year can be carried over from year to year until the end of the competing segment. At that point any unspent funds would be returned to the sponsor. If the award does not specifically allow for carryover, the unobligated amount will be restricted and also removed from the billing limit at the end of each budget year. At initial check-in, review is undertaken of Notice of Grant Award for carryover terms. If nothing is stated, then the award does not have carryover authority per NIH GPS.
