

## Foreign Air Carrier Exception / Fly America Act Waiver Form

The Fly America Act requires that foreign air travel funded by the U.S. Federal government shall take place on U.S. Flag air carriers unless one of the exceptions in the below checklist is applicable.

**NOTE:** US Flag carrier service is considered available even though:

- a) Foreign air carrier service could be provided at less cost or
- b) Foreign air service is preferred by or is more convenient for the traveler

**Instructions:** Refer to ASRSP website page "Traveling on Sponsored Projects" section "Use of Foreign Air Carriers on Federal Funds" for more information.

This form is to be used to document the justification for an exception to the requirement that foreign air travel funded by the U.S. Federal Government shall take place on U.S. Flag air carriers. In order to assist a traveler in determining if a request complies with the law the form is divided into two sections

- a) a check list which identifies the acceptable reasons for waiver and
- b) a certification statement which must provide detailed information about proposed or past flight.
