Fire Extinguishers	29 CFR 1910.157	<a href="#">Online*</a> required for all initially and annually thereafter; <a href="#">In-Person</a> , hands-on required for all who perform hot work and recommended for all others initially and annually thereafter	
First Aid and CPR/AED	29 CFR 1910.151	In-Person <sup>4</sup> recommended for all (at department's discretion) initially and every other year thereafter
