Motion: Whereas, on March 26, Regional Office 13 of the National Labor Relations Board ruled that grant-in-aid scholarship football players at Northwestern University are employees of the university, and entitled to a vote whether or not they desire to be represented for collective bargaining purposes by College Athletes Players Association (CAPA); and

Whereas, the Administration of Northwestern University has declared its intention to appeal this decision, basing its appeal among other grounds on the argument that scholarship football players at Northwestern University are primarily students, and secondarily athletes; and

Whereas, the Faculty by statute have a fundamental responsibility at Northwestern for decisions on academic issues, and the University's appeal argues that this is an academic issue; therefore

Resolved, that the Faculty Senate requests that before any appeals are lodged, the University consult with the Faculty Senate, to ascertain the level of support among Faculty for such appeals.
