

**SUMMARY ANNUAL REPORT FOR
NORTHWESTERN UNIVERSITY MEDICAL HOSPITALIZATION INSURANCE PLAN**

This is a summary of the annual report of the Northwestern University Medical Hospitalization Insurance Plan (Employer Identification Number 36-2167817, Plan Number 506) for the plan year 09/01/2014 through 08/31/2015. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has an insurance contract with Blue Cross Blue Shield of Illinois to pay certain stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ending 08/31/2015 were \$677,666.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$8,053,277 as of the end of plan year, compared to \$10,767,987 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$2,714,710. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$68,146,756 including employer contributions of \$49,841,809, employee contributions of \$18,287,139, and earnings from investments of \$17,808. Plan expenses were \$70,861,466. These expenses included \$3,671,360 in administrative expenses and \$67,190,106 in benefits paid to participants and beneficiaries.

6. Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.
