## **Graduate Student Union Funding Matrices**

Please use the following two matrices and the below definition to determine whether a graduate student is eligible for inclusion in the bargaining unit based on the services they provide Northwestern. Please use the correct funding codes and job titles to designate students for union or non-union eligible roles in our systems as outlined in these matrices.

## **Bargaining Unit Definition:**

The Bargaining Unit is defined as:

Graduate students enrolled in Northwestern University degree programs who are providing instructional and research services for the University, including graduate assistants, teaching assistants, research assistants, and fellows.

The following groups are explicitly excluded from the bargaining unit:

All other employees; graduate students who are not providing instructional or research services for the University; undergraduate students; graduate students not seeking Northwestern degrees, including visiting students; graduate student graders, tutors and proctors who are not otherwise providing instructional or research services for the University; Assistant Chairs in residential colleges; Residential Assistants; students enrolled in the Pritzker School of Law; M.D. seeking students in the Feinberg School of Medicine (including M.D./Ph.D. students in Feinberg who are in their M.D. phase of studies); students enrolled in the Medill School of Journalism; office clericals; managers; guards and supervisors as defined in the Act.

## **Operational Definition**

Graduate students (other than MD students, including MD/PhD students that are in the MD phase of studies; Medill students; and Pritzker students) are eligible for the bargaining unit if they provide instructional or research services. See the "Category Examples" section in the Union and Non-Union matrices on the following pages for examples of services that are/are not

<sup>\*\*</sup>Student temp (union), student temp (non-union), or Instructor (S) (job code 101325) appointments may be used instead of the above stipend appointments. However, for receiving financial aid, especially loans, the above types of stipend appointments which are entered in CAESAR/SES must be used. TGS recommends entering the funding for active TGS PhD and MFA students in CAESAR/SES rather than using temp payroll unless the role specifically requires that the student track their hours in the timekeeping system.

# TGS has reviewed internal fellowships and interdisciplinary assistantships and provides the following guidance on the nature of the work they provide.

## **Fellowships:**

Most internal fellowships or endowed funds may be used to pay student for bargaining unit eligible roles. However, some fellowships are explicitly awarded to provide students time to make progress on their own academic research and work and cannot be used to fund bargaining unit roles. Examples of these types of fellowships include the Presidential Fellowship, The Nicholson Fellowship, and the Ryan Fellowship. Many of these fellowships awarded for student's own academic research are competitive awards or dissertation year fellowships. Student awarded these types of fellowships may not be asked or expected to provide instructional or research services for the University in exchange for these funds for the duration of the fellowship. Please check with the unit that oversees an award/fellowships to see whether it can be used for bargaining unit eligible work before asking students to provide those services for the University.

## **Interdisciplinary Assistantships:**

Based on conversations regarding the work historically performed by these roles, TGS believes has determined which titles/codes best match the roles for interdisciplinary assistantships. - > Additional/Special Pay cannot be used for union-eligible pay; any student receiving additional pay for union-eligible work must be paid on a union-eligible appointment.
- > Pay Group, Posn Type, or Posn Catgory cannot be used to identify union eligibility; some codes, such as the MGW paygroup, can be used for non-union or undergraduate work.
- > Union-eligible job codes automatically apply union dues to relevant earnings, provided the union has submitted the student's signed dues deduction card to HR.
