Federal Documents

Social Security

- \$0.00
- No medical evidence required
- M or F markers only
- 2 forms of ID:
 - Proof of citizenship (birth certificate, certificate of naturalization, or passport)
 - Birth certificate, passport, state ID, driver's license, school ID, employee ID, health insurance, or military ID.
- Visit office

Passport Book or Card

- \$30.00 (Card), \$130.00 (Book), \$60.00 expedited
- 4-6 weeks, 2-3 expedited
- M, F, or X marker
- If updating valid (unexpired) -- Application form DS-82
- If applying for new or with expired passport -- Application form DS-11
 - 2"x2" color photo
 - Proof of citizenship (birth certificate, certificate of naturalization, or passport)
 - Proof of ID with signature (e.g., prior passport, state ID, driver's license, or military ID)
- Changing any passport info within one year of new passport application – Application form DS-5504
- Visit acceptance facility

Illinois Name Change Required Elements

IL Legal Name Change Eligibility

- Proof of 6 month residency in IL at time of filing petition
- Cook County residents need birth certificate (any state) or passport with filing
- Those with felony convictions need to have fully completed any sentence
- Fee waiver (income threshold) OR ~\$388 filing fee
- Publication waiver OR \$75-200 to publish your name in a newspaper
- Additional requirements apply if under registry mandate

Illinois/Cook County Name Change Process

Example: Cook County

For Filing:

1. Civil Cover Sheet
2. Name Change Petition
3. (Proposed) Name Change Order
4. Proof of Residency (IL ID, lease, etc.)
5. Birth Certificate or Passport
6. (If Criminal Record) Disposition Sheet
7. (If Prior Name Change) Photocopy
8. Proof of Publication *OR* Motion to Waive Publication + (Proposed) Order Granting Publication Waiver
9. Filing Fee \$388 *OR* Motion to Waive Fee

Example: Cook County

For Hearing & Retrieving Order:

1. Judges randomly assigned at filing
2. Hearing dates vary by judge
3. Petitions filed in Dec are scheduling for Feb – May 2025
4. Hearings on Zoom (video)
5. Electronic order is emailed
6. Exchange printed copy of electronic order for stamped, certified Name Change Orders available Daley Center 12th floor (\$9/copy without fee waiver)
